SECTION 1000 CLUB AFFILIATION

1001 GENERAL REQUIREMENTS

Membership to the ISAI may be granted to any organisation, whose main objectives are the development and support of as a leisure or competitive sport of Irish ice skating and skaters. Ice skating disciplines are as defined by the ISU.

1002 ISAI "CLUB" MEMBERSHIP BENEFITS

1. Advice and support with administration;
2. Wavier of all permit and sanction fees for all Club run competitions, Exhibitions, Shows;
3. Discount on rates at ISAI seminars and workshops;
4. Access to ISAI officials and Judges;
5. Contact information on the ISAI website.

1003 MINIMUM REQUIREMENTS

The following minimum requirements for Club / Organisation membership in the ISAI shall be required. Other conditions may also be established by the Board from time to time.

1003.1

Have been organised pursuant to a duly adopted Constitution and/or By Laws;

1003.2

Have duly elected officers and committee; all officers must not be *ex officio* of any other club or organisation with similar objectives and focus.

1003.3

Have at least 3 members who must form the committee of which it is mandatory one is a Child Officer.

1003.4

Solvent finance funds

1003.5

Have a minimum of insurance necessary to meet the activities of the club and provide protection to the committee. The ISAI will bear no responsibility for the club.

1003.6

Have adopted and published rules for the orderly conduct of their members and respective activities, including club competition;

1003.7

Have accepted the ISAI Constitution and Rules and the ISC Code of Ethics and Anti-Doping Rules, including amendments thereof, as a condition of participation in their activities

1004

APPLICATIONS FOR MEMBERSHIP

Applications for membership of the ISAI must include at least the following documentation:

1004.1

A formal application in writing, which shall include the acceptance by the applicant of the obligation to comply fully with the minimum requirement.

1004.2

A copy of the Constitution and published rules of the applicant

1004.3

A listing of the members or officers of the committee;

1004.4

Copies of required insurance, if appropriate.

Evidence of financial stability

1005 RENEWAL OF MEMBERSHIP

Membership must be renewed on the annual date of affiliation. It is the clubs responsibility to provide continued evidence that they continue to meet the minimum membership criteria.

1006 RULE CHANGES

Following membership acceptance, it shall be the responsibility of the Club concerned to notify the ISAI of all changes in the documentation originally submitted above.

1007 ACCEPTANCE OR REJECTION

1. The Board shall act on membership matters at meetings only and shall decide upon the acceptance or rejection of all applications for membership.
2. The board shall provide reasons for all organisations rejected
3. The board shall make recommendations to all organisations rejected on what they need to achieve in order to meet the affiliation criteria.
4. A rejected club may reapply at the next sitting of the Board

1008 VOTING RIGHTS

Membership does not include ANY voting rights in the ISAI, these are as determined by the ISAI Memorandum and Articles.

1009 INDIVIDUAL MEMBERS

An individual's membership of an affiliated club/organisation does not grant automatic individual membership of the ISAI. All individuals must join the ISAI independently.
